

MEMBERSHIP: CORPORATE ACCOUNTS

Our current membership consists of Nurses, Podiatrists, Wound Specialists, Doctors, Occupational Therapists, Sports Physiotherapists, Dietitians, Aged Care facilities, Commercial companies etc. **We also offer a *Corporate Account* membership designed for larger organisations that have more than five staff interested in wound care.**

If you have five staff or more, then a Corporate Account is an exceptional deal.

Note that Corporate ACCOUNT is one person, usually the education coordinator, that is responsible for payment and supply of staff lists.

The Corporate Members are the staff linked to the Corporate Account via a coupon code.

You can have up to 20 staff for each Account, costing \$240 + GST (excellent value as it gives access for up to 20 staff, Full membership is for \$69).

An organisation can purchase more than one membership (e.g. 20 + 20 staff, or say, 20+20+10)

Corporate Member benefits are as follows:

- Access to the 'Members Only' section of the NZWCS website
- FREE access to '2019 International Pressure Injury Clinical e-Guidelines'
- Tissue Issue (two monthly educational newsletter)
- Reduced registration fees at NZWCS events
- Reduced registration fees at the NZWCW biennial conference
- Online access to wound related education modules & seminars
- A collection of links to the best free online journals
- Eligibility to apply for Awards, Scholarships and Research Grants
- Advance notification of education opportunities (via your Corporate Account manager)

The role of the Corporate ACCOUNT holder

This key person, arranges payment and liaises with the NZWCS Administrator. A unique coupon code is assigned to your organisation which you then pass on to staff. This Coupon reverts the staff membership fee to zero.

For large organisations that join the NZWCS for the first time you can have the option of providing a CSV file of staff details, these can be uploaded by our administrator– this will auto-send a welcome

message and login instructions to your staff. Subsequent years staff will renew or create memberships themselves.

The Corporate Account manager is to forward all NZWCS emails to staff*, and occasionally provide the Administrator with updated staff lists. All notices are available online in the Portal.

*Note you now can request that staff receive notices directly – you MUST email the administrator for this special request.

Money, invoice, receipts

When you apply for membership you have the opportunity to enter a Purchase Order number which will show on the auto-generated invoice instantly emailed to you. You then either pass this onto your accounts person, pay online, or pay online using a card.

Staff Membership

Staff go to our website and create a new corporate membership. The coupon code reverts the charge to zero. They enter basic contact information to create the membership. They will automatically receive a membership number which they can then use to get discounts at conference or local study events.

Sometimes there may also be a staff member within your organisation that will become a Full Member to enable voting at the AGM or participate in the National Committee to help steer the Society. Full membership at this level gives participants access to international information and higher-level collegial opportunities.
